Land and Property Registration

Digitising legal administration processes streamlines and accelerates the land application and registration process. ICE Parks manages the entire process, including the renewal and payment of the land transfer registration and the ownership transfer when required.

> Quota management

The quota system inherently protects the park from being over-utilised or prevents any one party benefitting unfairly from a national asset. Checks and balances are in place during the quota application process where environmental professionals are involved in reviewing and verifying the application.

ICE Parks helps national parks manage the animal population and park resources responsibly by monitoring quotas and quota disbursements. The quota is available to a verified legal entity and ICE Parks manages the application process from

submission until the quota certificate is issued. It processes payment for the quota certificate and verifies the applicant's identity and quota details.

› Hunting Permits

Hunting permits exist to regulate the utilisation of game to protect natural resources for the future and sustain the population of certain species.

A limited number of permits are issued, and hunters must specify on their application the exact species they will be hunting. The permit is issued for species where there is an approved quota, and the species quota must be within the approved balance for the current year.

There are two types of permits:

- The primary permit approval process may involve several individuals to ensure all factors are considered before approving the application. The approval process may include stringent qualification criteria, especially where specific species require careful management.
- A hunter may apply for a secondary permit if they intend to hunt other species. However, a primary permit must already be issued and within its validity period.

› Tour Operators

Tour operators stimulate ecotourism and generate valuable revenue for national parks. ICE Parks facilitates the registration and management of tour operators and manages the process through to payment processing. It applies similar stringent criteria with multi-tiered approvals to verify the tour operator's eligibility and ensure parks are not overburdened with visitors.

› Auditing & Reports

ICE Parks provides accurate data on the whole operation's management, staff, activity in the park, people and organisations using the resources, and revenue collection. This information assists with audits to ensure resources are being managed appropriately.
